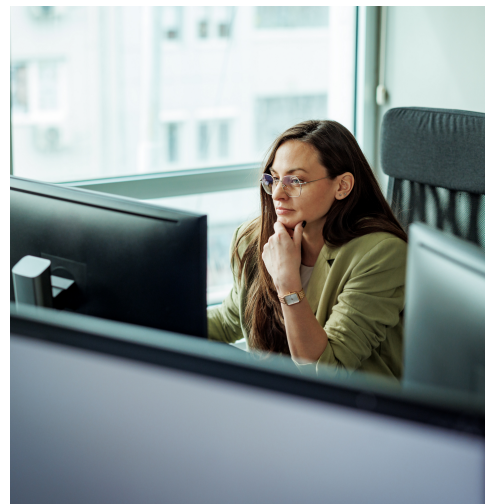

- And the Scrum Master, accessibility SME, and engagement leader served to bridge the gap between Judge's team and the client's business leaders.

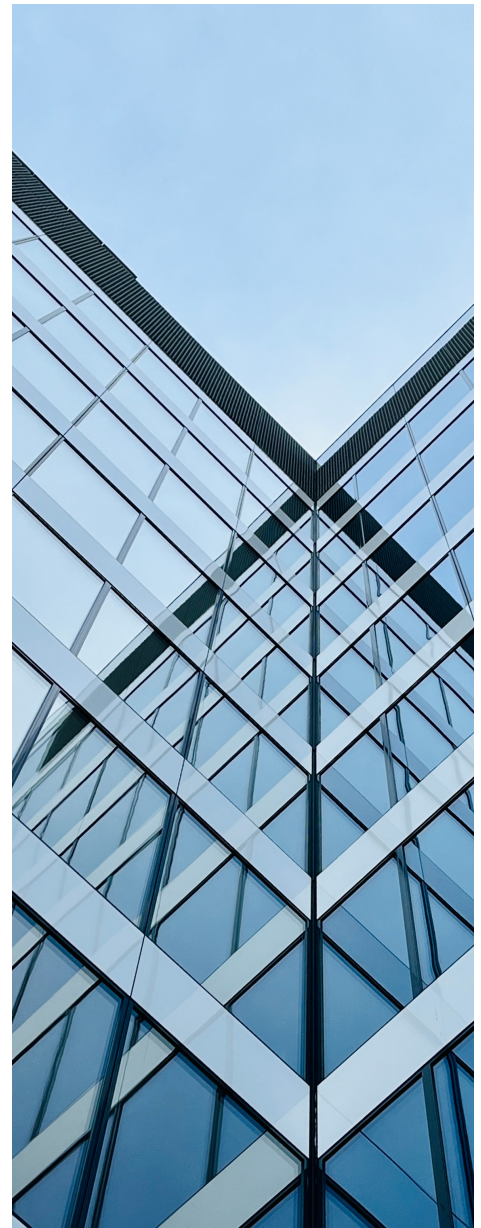
